DEDHAM BOARD OF HEALTH MINUTES June 21st, 2018

Meeting called to order at 5:30 Minutes from May 10th accepted First order of Business

Leanne Jasset Chairperson starts with the Directors report

1) Catherine Cardinale Health Director states that Giorgio Petruzziello is here to discuss 338 Washington St houses Blue Ribbon BBQ and El Centro Restaurant. Mr. Petruzziello is responsible for maintaining, record keeping, and monitoring the grease trap which is shared by both restaurants. This will be the first time that the owner of a property is going to maintain the grease trap as opposed to the Restaurant owners. It is 2500 Gallons and is extremely large and after speaking with engineering and plumbing they are confident in the decision and will monitor it for a year.

Leanne Jasset, wants to know who made the decision to allow this size of a grease trap to be installed and wants to know who regulates it and who signed off and made the

final decision.

Catherine Cardinale says that all three departments, Engineering, Plumbing and the Board of Health all have a say, the Board of Health doesn't necessarily "sign off" but they review. She is not sure how the chain of command fell apart or how this happened, and she believes that the building department will look into more regulations regarding.

Leanne Jasset, wants to know if we are they regulatory board, how something like this

could happen with the Board of Health knowing.

Catherine Cardinale agrees that there is some misunderstanding, and she spoke to Mr. Petruzziello and wanted to move forward for now, and then look back and see how to

make sure it doesn't happen again.

Leanne Jasset wants to be clear that we will not set a precedent for other restaurants. Catherine Cardinale states that Mr. Petruzziello is well aware, that he will be monitored, and if it is unsatisfactory he will need to put in a separate grease trap. It is not uncommon in other parts of the state to share grease traps. Catherine would like to make sure that both restaurants are equally responsible and would not like to see the establishments shift blame on which establishment is responsible for maintaining it. That is why she allowed Mr. Petruzziello be solely responsible so these types of things don't happen.

Giorgio Petruzziello, states that when they first started building this site, it was scheduled for a smaller trap, however he does not believe that it was an

oversight on anyone's part, but is relived that the size is adequate to handle both restaurants and is fully aware that if it fails he would need to replace it.

Patty Roberts asked that why if he knew that it was a large grease trap, why did he decide to go ahead with it anyway?

Mr. Petruzziello cleared up that he didn't know at the time that the size of grease trap was so large, however once it arrived to the site he decided to go along with it.

Catherine Cardinale concludes that 2500 is large enough to handle, as 1500 is the minimum grease trap used as a minimum, and is a large tank as is.

 Catherine Cardinale says that it has been an enormous issue with the high school/jr high crowd, and that Jessica is aware.

Leanne Jasset asks if it's possible for Jessica to submit a summary about what the Drug Coalition has done, and what they are currently working on.

- 3) Kathy Reda attended, the meeting with the Superintendent of Dedham Schools, to decide on curriculums and how they are planned, using the metro west study, they are aware which years are most prevalent (8th grade summer until the 9th grade). They are aware that prevention is the biggest tool for fighting against, and it is now included in the curriculum in the High School
- 4) Patty Roberts talks about the Opiate Crises and the representation at the Flag Day Parade. The Church of the Good Shepard, has hired a renowned pastor that has published signs regarding the amount of opioid deaths per year that will be coming to speak.
