## **Public Comment**

Brian O'Connell stated he was representing Dedham Boys & Girls lacrosse, he states that lacrosse needs a home field, and that he wanted it on record that lacrosse needs a field that is dedicated to just them as it is only a three month sport, he was disappointed that Gonzalez Field was lined for soccer and not lacrosse.

#### Minutes

- S. Radner stated that the reason for doing Park & Recreation & Open Space to together, was so that things would be parallel.

Steering Committee will meet in two weeks and Horsley & Whitten will send information as it is completed.

#### Open Space and Recreation Plan Discussion
