

Swim Team chronides the overwhelming struggles and extraordinary triumphs of 3 young athletes with autism and shows how a swim team can bring hope to a community. (2016, 90 minutes, followed by discussion)

13 year-old Zoe wants nothing more than to simply go to school, learn, have fun with friends and be a kid. Unfortunately, ignorance and intolerance have not always made this easy. Zoe, with the help of her mother and the ACLU, fought school officials for her right to self-identify in school. Even in the face of bullying and endless teasing from both school officials and students, Zoe determinedly continues to live her life and tells her story in the hopes of helping others persevere in living their authentic lives. (2016, 54 minutes, followed by discussion)

Transgender Kids: Who Knows Best?

Around the world there has been a huge increase in the number of children being referred to gender clinics. Increasingly, parents are encouraged to adopt a gender affirmative approach - fully supporting their children's change of identity. But is this the right approach? (2017, 59 minutes, followed by discussion)

Feb 17: Miss Representation

Miss Representation explores the under-representation of women in positions of power and influence in America, and challenges the media's limited portrayal of what it means to be a powerful woman. (2011, 80 minutes, followed by discussion)

Feb 24: Underwater Dreams

Underwater Dreams, narrated by Michael Peña, chronicles the story of how the sons of undocumented Mexican immigrants learned how to build underwater robots. And go up against MIT in the process. (2014, 86 minutes, followed by discussion)
