Dog Park

- C. Dello Iaconno stated we have new gating, and fencing, and are installing security cameras, he is asking the Commissioners if he can have their approval go forward working with the Director, on the Dog Park, and then report back to the Board.
- R. Stanley stated that there will be a FOB system and new security cameras in place
- C. Dello Iaconno stated that we may need to be increase fees for Dedham residents to use the Dog Park, however, he will work with the Director on that
- J. Maher asked that there be a Saturday that residents can register their dog for the Dog Park.

Master Plan Update

- J. Maher stated that Horsley Whitten has sent the editable document to the Director, Dan Hart and himself. Master Plan committee members, Tracey White and Stephanie Radner will make final edits and corrections, such as spelling errors, addresses, etc. He explained that no content changes will be made.
- C. Dello Iaconno stated that he with R. Stanley had met with Assistant Town Manager, Nancy Baker. N. Baker explained the process of the Master Plan to him, as he was under the impression that the Commission could make adjustments to the Master Plan, however that is not the case at all. Once the Master Plan Committee is done with the document, and has presented to the Commissioners and Town Meeting it is a completed document and no additions or subtractions can be made.
- C. Dello Iaconno then asked that J. Maher and T. White bring back to the Chairman, that he is officially asking that the wording "Heritage Rail Trail" to be omitted from the final document, as it doesn't exist, he stated that he has seen it in the document at least three or four times, and I would kindly ask that you remove "Heritage Rail Trail" from the document as it pertains to this Commission.
- J. Briggs stated that he does not necessarily agree with It should be called the abandoned rail corridor

Sub Committees

Leash Law / Policy – there are many people that use our fields responsibly with dogs on leashes and maybe time to make room for the Dog families.

J. Maher stated that maybe ball fields that are not used from after Fall season to right before spring season starts

Lisa Moran, a resident, asked about signs being put at the parks, in regard to dogs and animals on the fields, C. Dello Iaconno answered that he and T. Donahue, would be working on that and she was more than welcome to share her thoughts and concerns

Alix O'Connell, a resident stated that maybe the Commissioners could look at Brookline's policy. C. Dello Iaconno stated that he actually helped write that

J. Mahers asked about the Manor Fields Committee and possibly limit to two Commissioners C. Dello laconno, stated that he would step down from the Committee for 61 days until the election, and then put himself back on the Sub Committee after Commissioner Ledda is no longer a Board member.

Director's Report

R. Stanley stated that he had attended the Capital Expenditure Meeting and the four items that they requested are, netting for the fields, a truck (one is 3 years old and one is 13 years old) Concession Stand, Pickle Ball Court- the DPW Director stated he could possibly help us, and that could reduce the cost.
