Public Comment

Rita Mae Cushman thanked R. Stanley for his assistance with the National Night Out event at Condon Park. She stated that the Trails day event was great and thanked everyone involved in making it such a great day.

Mark Rogers, 28 Fulton Street has concerns about the proximity of the proposed Gun Store to Condon Park

Jeanette Chevere, of 88 Emmett Avenue does not think the proposed Gun Shop is good for the neighborhood

Permits

After much discussion, the following applications were voted on,

<u>Dedham High School</u> - J. Maher made a motion to accept the permits as requested, seconded by L. Moran, all voted in favor of the application

<u>Dedham Youth Baseball</u> - L. Moran made a motion to accept the permits as requested, second by

J. Maher, all voted in favor of the application

<u>Dedham Youth Soccer</u> – J. Maher stated that there is a lot of wear and tear on the pool field, Paul Yandrisevits, the President of Dedham Youth Soccer stated that they would use the Practice field next to Avery School for practice and only use the pool field for games. J. Made a motion to accept the permit, L. Moran seconded the motion, all voted to accept the DYS permit.

<u>Dedham Pop Warner</u> requested Memorial Park from 5 – 8 Monday thru Friday, and Saturdays from 8:00am – noon J. Maher made a motion to accept the permit request with a second from L. Moran, all Commissioners voted in the affirmative

Dedham Girls Softball requested Sullivan & Loewen field on Sundays from 10:00 am to 4:00 pm, the Director informed the Commissioners that the Dedham Girls Softball Pumpkin Bowl Tournament would be held on September 20th and 21st. J. Maher motioned to approve the permit and Pumpkin Bowl event, L. Moran seconded his motion and all voted to approve the permit.

Soccer Sisters and Vikings requested Gonzalez Field on Sunday from 8:00 am - 10:00 am, The Directors stated that they share the field, though they both put in a permit. J. Maher made a motion to accept the permit, L. Moran seconded the motion, all vote to accept.

Ursuline Academy asked to use Frietas field for their games from 3:15 to 5:15, J. Maher made a motion to accept the request, L. Moran seconded the motion, all Commissioners voted to accept the request.

Dogs in Parks

J. Briggs stated that he had been asked about allowing dogs in neighborhood & community parks, however since the person that had asked to have the discussion wasn't able to make it, the agenda item would be tabled to another meeting.

Gun Shop Proximity to Condon Park

- J. Briggs stated that he had attended the rally and it was all positive and there were quite a few people there, he also stated that he personally doesn't think it's the best to have that business next to a park, however legally we cannot do anything
- J. Maher stated that ideally don't want it near Condon Park or the Fire Station or not the best towards the revitalization of East Dedham Square area, the owner filed all the proper paperwork, it is the responsibility of residents to watch the agendas of various Boards, residents should send letters to the various Boards sharing their concerns
- L. Moran asked if the Police Chief can deny the applicants request.
- J. Briggs stated that was not in our purview
- J. Maher asked that the Commission send a letter to the Board of Selectman, stating the concern about the Gun Shop being so close to Condon Park
- J. Briggs stated that he would be happy to do so

Laurie Toomey of Richards Street asked that the Commission send a letter to the appropriate Boards stating the number of children that are at Condon Park through the permitting process

Jeannette Chevere asked if you can carry a gun in a playground, and would it be possible to have playgrounds to be gun free zones

Gentleman from River Street asked if there was any law that prohibits gun stores near parks or schools

- C. Dello Iaconno stated that they must be 500 feet from a park, school or senior housing
- L. Toomey stated that is a one to one half walk from the park
- J. Briggs stated he will draft a letter to send to the various boards
- J. Maher stated that historically businesses don't last long in that location
