

### **SEWER SURVEY RESULTS**

October 2019

The Engineering Department would like to thank all that took the time to fill out a sewer survey over the summer. We thought you would be interested in seeing the results. We received 1,330 responses of which 773 (58%) of the responses were performed online and 557 (42%) of the responses were the paper surveys that were sent out in everyone's sewer bill and mailed back to Engineering Department. Below are the results of that survey for your reference. Our intent is to use the data collected from this survey and incorporate it into the Private Infiltration Removal Policy that we will be presenting to the Select Board this fall.

<u>Q1:</u> In your opinion, who should be responsible for the cost of repairs to sewer pipes on private property (the lateral pipe that runs from the main sewer line to your home or business)?

The property owner should pay 100%	8% - 101
The Sewer Enterprise Fund should pay 100%	61% - 800
It should be shared between the two	32% - 416

**Q2:** Assuming the property owner is responsible for 100% of the cost, how long should they be given to complete the repair?

#### **Q7:** Assuming the costs will be shared, how much do you think the Sewer Enterprise Fund should pay?

A fixed amount regardless of the costs of the repairs (e.g. \$2,500)	7% - 89
