Survey	Q1	Comments
Online	Shared	1. We think there should be hardship exceptions available on a case-by-case basis that could apply, for example, with regard to the time given to complete repairs, assessment of financial penalties, and the percentage paid by the property owner. We think the hardship exceptions should consider income and expenses, not solely income. There should be an income cap where a property owner is not eligible, but the cap should be fairly high, like \$500,000 or more. Income should be determined from documents like Form W-2s, not taxable income. 2. It is possible that pipes were damaged from municipal and utility construction work, so that is a reason why we think the Sewer Enterprise Fund should be accessible. 3. Property owners already pay to have the clean water treated, so it makes sense to us that all of us contribute to repairs through the Sewer Enterprise Fund, as we are all benefited by the repairs. The burden is shared, so the solution is shared. 4. Related to #3, if there is going to be a threshold determination made as to which leaks must be repaired now (i.e., only leaks with a certain amount of infiltration), which results in some property owners not having to make repairs, this should militate toward greater contributions from the Sewer Enterprise Fund. It becomes luck of the draw and there is no wrongdoing by the homeowner, yet it could be a huge financial burden. Again, all property owners benefit from the repairs, so we should all contribute. Thank you!
Online	Shared	A financial penalty should only be applied if the homeowner is flagrantly delaying the repairs. Service providers may delay completion due to scheduling or owners due to financial restrictions. Also, some homes are set back from the street and may incur significantly greater costs. These owners should have access to increased support or better loan options. Not many people even think about this kind of a situation when purchasing a home.
Online	Shared	A major issue that is not addressed is the fact that there is not a separate meter for water vs sewage use. Homeowners should be allowed to enjoy pools, lawns, etc. without being billed as sewage. Thank you.
Online	Shared	Any assistance from the SEF should be based on household income of the house in question.
Online	Shared	Are you planning to provide the status. progress, etc. on this website?
Online	Shared	As we have personally experienced, sewer line repairs are a costly undertaking and for residents on a fixed income, having to bear the brunt of the repair alone could be financially devastating. Perhaps the town should consider in addition to sharing the cost, an income cut off so that those who are still in their own residence but have an annual income of X % of the poverty level would have the total cost paid out of the sewer fund.
Online	Shared	As with most surveys, there is a lot of grey area to answering most of these questions. In general, the Town should try to make this process as painless as possible for the affected property owners. Ultimately, every affected property owner wants to limit their financial exposure. As every property owner benefits from having the problem resolved, every property owner should share in paying for the solution. To that end, the Sewer Enterprise Fund should pay the maximum percentage based on a ratio of all the affected property owners/cost to repair each individual property. That's an overly simplistic equation, but the goal is to ensure those at the higher end (\$20,000) are getting more support from the Fund than those on the lower end (\$5,000) in proportion to their property's percentage of the total project. Also, any additional arguments to the value of this project (beyond better controlling sewer costs) should be explained, e.g. higher property value. This would hopefully make the costs associated with the project more palatable to those ultimately affected.

Online	Shared	Both the Town and Homeowner should pay for these repairs as both parties will receive benefits of the repair, and the consideration afforded the homeowner should be reflective of their limited ability to construct, care, and control the said sewer line.
Online	Shared	Consideration should be given to owners who because of age or income cannot pay for the repair. Interest free loans should be given to residents rather than low interest loans. Residents should be given estimates for the work and contractors should be carefully vetted before placed on a list of acceptable contractors. PRIVATE WAYS SHOULD NOT BE TREATED ANY DIFFERENTLY THAN ANY OTHER STREETS.
Online	Shared	Dedham seems to be behind the times in terms of communication. Many important pieces of information are published in the paper, as I understand it, but I question how much of the population is consuming information in that way. Especially I f the home owners will be responsible for the cost or a potion of, I'd ask the town to be thoughtful in their communication plan and what various methods will be used (with all town matters, actually). Thank you!
Online	Shared	Depending on how far someone's home is from the main pipe, this could become prohibitively expensive for some homeowners, or a large loan burden. Seems harsh even though town regs say it is homeowner burden. I would think not many people are aware of who shoulders the cost for something like this. Since this issue would theoretically affect 7% of people as inspections continue each year, and the Sewer Fund is theoretically built up to take care of large, one-off capital expenditures, it seems reasonable to use most or all of it to defray the cost for affected homeowners. They originally paid into this fund with their fees anyway. To make everything equal for those affected, capping the amount a homeowner has to pay seems fair.
Online	Shared	For question #3, instead of a financial penalty, a lien should be put on the house. Shouldn' clean water distribution pipes be addressed at the same time?
Online	Shared	Home owners identified as one off the 113 affected by this project should be notified immediately
Online	Shared	How do residents know that you are being truthful with regards to private infiltration issues? In your presentation, it says that only those property owners that have been identified to have infiltration will be subject to the removal policy. Do we residents get to see the actual results of the inspection done on our sewer lines? It says only 1,600 sewer lines have been inspected and only 113 have been flagged as having infiltration problems.
Online	Shared	How will residents be notified if their sewer needs to be replaced?
Online	Shared	I believe the situations need to be spelled out, categorized, pooled and then the costs woul support the situation. A couple of scenarios and suggestions to start a conversation. original pipes fail (which the town choose the materials that could have been 100 years ago based on the options at the time) - town provides replacement options and if it's the current general choice (cost is shared 50/50), but if the home owner decides they want some new gold standard (cost for town could be 25% and home owner 75%) New town standard pipes fail within 25 years (90% town and 10% owner). The first assumption should be town qualified companies providing the services and they qualify the companies providing the materials - this puts companies bidding on notice that their work is their responsibility. If you want Dedham to be a place for people to say I like how they manage for townies and not for the companies that provide the lowest bid and not own it down the road, please consider something along the lines I mentioned. We moved into Dedham in 1963 when it was smaller and still had farms - managing the things you can manage for the people that want to live here count. This is still one of the few things townies will notice and having consistency in your neighborhoods does matter for those that take to time realize what can/can't be done.

Online	Shared	I don't agree with a time limit if it isn't paid by the sewer fund
Online	Shared	I have lived here for my hole life and I am now disabled I would love to stay here but being on a fixed income living here is getting harder and I know if I was able to still work it would not be a problem but the town needs to help people like me and the elderly to be able to stay in we're homes thank you
Online	Shared	I think to truly make this decision, it would be helpful for the people of Dedham to know the range of costs for these repairs. Answers may differ greatly depending on the over all cost of this. While I understand that it will likely be different on every property, I am sure there is a range that can be given.
Online	Shared	I went thru this already. My house is sout of pocket which had to be done immediately. In fact, my project was one of the first and nobody knew what to do. The then DPW head, so libelieve but I have files filmed the entire process as a template for future incidents and funny how the town is addressing this years later? The town had no plot plan? Why? Thankfully my neighbor did. They did recommend the original contractor who you people still use? Why? He should be canned. Why, when his father did our original job he used one line for me and the neighbors. Then they suggest I use him again, great idea. Call me, so leave the street 10 ft into my property. Second, the then plumbing inspector, wanted the new lines, yes my neighbors chipped in yet they had no obligation by drilling new holes into our foundations and thus storage areas. Real great move until I screamed at him and won. Anyways, around \$15K plus, new 130 ft lines all out of my pocket with some help from the neighbor, your addressing this. Just a little bitter but my responses were well thought out and fair. Finally, why not give people like me a break for money I pay for my sewer bill now knowing part of it goes to a problem I fixed years ago. That is unfair to me and frankly I am miffed to this day they made me pay for town pipes on town property, now this. I could understand paying for my line but the towns, nope. Then using me as a template; the contractor still being used by you as a so called certified sewer replacement expert, I think not after seeing the original lines. If I had the funds then I should have sued him. BTW The company I selected were friends and major commercial contractors you still use and others throughout Mass. As I suggested, it is fair to say I know quite a lot about the process unfortunately. In fact, my original plumber and former friend have not spoken since that dayhe found the issue but made it worse and I even have a \$500 VCR of my original line. Yes not too happy with him. Also, someone came close to being decapita
Online	Shared	If property owners are required to pay all or part of the cost, offering a low interest loan and giving sufficient time to complete the repairs is critical. Many families will likely to struggle to afford such an expense. The Town should also consider a hardship waiver or delay. No one should lose their house because they cannot afford to make these repairs.
Online	Shared	If the necessary repairs are required by clear actions of the homeowner, they should be responsible for 100%. If it is just aging pipes, the costs should be shared
Online	Shared	If the owner is required to cover 100% of the costs, it's necessary to allow them time to come up with that amount of money, especially if it can cost up to \$20,000.
Online	Shared	If the town imposes a fine on noncompliant property owners, it should also perform the repair on their pipe once the total from the fines matches the cost of the repair.

Online	Shared	If Town furnishes pre-qualified contractors will the Town be held liable for any of the damages or sub standard performance?
Online	Shared	In completing of this survey it would be helpful to know 2 critical pieces of information: 1.) Is my specific property affected? 2.) What's the approximate cost to repair (understand it may vary, but a range or at least a minimum \$ amount would be helpful to get a better idea). I understand that sharing cost of repair with town may be a difficult thing to execute, but perhaps a good middle ground would be to offer financial assistance to resident if cost exceeds certain \$ amount AND/OR based on resident's income level AND/O property size/type AND/OR cause of issue. As far as I can tell, such a progressive/flexible option isn't covered by the survey. Please consider for maximum fairness in how this may affect different residents with different life circumstances. Financial help may come in the form of split cost OR no/low interest loan. Either way would be acceptable in my opinion.
Online	Shared	It is about time that the Town faced this problem!
Online	Shared	It may be worth exploring some sort of incentive program to complete project completion quicker. For example, property owners can pay 100% of the costs themselves and comple over a 2 year cycle, or can pay 50% of the cost if completed within 1 year of notice. Considering some of the costs associated (as much as \$20k in some cases potentially), a 2-year timeline would result in too much unwelcomed blowback (in my opinion). I would increase the timeline to 4 years, and advise property owners they have 4 years to complet themselves at 100% of the costs, or 2 years with a 50% shared cost.
Online	Shared	It would be helpful to homeowners to have an estimate of how much it would cost per linear foot to repair/replace the sewer pipes on their property, so they know how much they will be responsible for and can be prepared for this additional expense. Many Dedhar homeowners are senior citizens on fixed incomes, so the more advance notice of this expense, the better.
Online	Shared	it would help to know what one might expect the cost to be.
Online	Shared	it's obviously a tough situation. I know from family just recently having to repair just 8 feet of sewer pipe from their house to the street cost over \$8k. This is a huge financial burden for most families. Most of these issues inflow/infiltration situation are from things that were done 50+ years ago. So to put the 'sins of the father' on the current home owner, seems a bit unfair. I know when I bought my home 10 years ago, there was no mention of this problem (and if it was, it would definitely be a negotiation point). Now, someone could have a huge bill because of the way the plumbing was sent up 70 years ago when the house was built (when I'm sure the code allowed for these things at the time). And what if someone happens to be far away from the street? or if their pipes come out the back of their house instead of the front? All things that most current home owners had nothing to do with originally and will now have to pay exorbitant amounts to fix. Because of this, I think it would be in the best interest of the town to work with/help pay for these services much as they can (I'd say 75% of the cost). In the end, we are already paying for the extra processing of water anyway. If we pay to repair these services, then it will only help in reducing future water processing bills in the future. The financing is a great idea. I would also say that if you have a list of 'certified' contractors, that these contractors be willing to
		give a 'discount' to be listed/preform these services. Thanks and best of luck

Online	Shared	My recommendation is a shared responsibility with a town-approved contractor. Negotiate with the contractor for a true favored rate. Let the owner go on their own contractor if they want but they must pay for it themselves this will ensure quality work is done and leverage the town's purchasing power to negotiate prices down. I do not agree with forcing individuals to pay for the repair 100% themselves and then impose a penalty if they do not. One reason is that Our elderly community is already squeezed with the inability to downsize homes and stay in the community further alienating this and other financially challenged populations is not the solution here. The second reason is that it sounds like it is a recipe for costly lawsuits. I have also heard of other communities leveraging a tax on new construction that pays for private sewer line remediation. We can be more creative and come together around this. I'm sure its not a unique problem.
Online	Shared	My sewer pipe ruptured and I had to replace a 9 foot section. This alone cost me \$10,000. To go from entry into the house to the street is about 30 feet, not in a straight line. Imagine how must that will cost, plus the repair to the yard and the driveway and fence that the sewer pipe passes under.
Online	Shared	private single family home owners should be given the most help and leeway to complete a town ordered repair
Online	Shared	Property owners in flood prone or high risk areas should receive an additional subsidy if infiltration occurs due to their increased risk.
Online	Shared	Regarding loans: Are the loans to the current property owner, or to the address? For example, if someone sells the property right before or after commitment to the work, who owns responsibility of completing and paying for the work? Should a sale be allowed, or made only with comment on the public records? Per Slide 15: How will owner receive proof of their exact property contributing to the issue? Per Slide 16: "Fair" payment terms should be made for each specific property, and perhaps like the tax rate and level of infiltration, and even considering CAUSE if known, should all go into the level of payment that the town offers. Can PPP be used here for other improvements, especially with commercial properties? Also, how are inspections/regulations for new connections being done to limit the amount of future impact on currently constructed or reconstructed buildings and water/sewer utilities? Per Slide 17: Six months, but certainly less than a year, should be required to do the work, with DPW providing multiple contractors qualified to do the work, and with negotiated rates that are advantageous to the homeowner. YES - an acknowledgement should be required, but the town (or its designee) should make considerable effort to ensure that notice is provided multiple times. Fees should be on a percentage of the work required, applied monthly - example - if repair cost is \$10K, monthly fee should be 1/12 of 33% of the overall fee. Per Slide 18: YES - refusal to allow work should incur a significant fee. It burdens everyone not just in Dedham but in MWRA system if someone if self focused instead of committing to greater good. Perhaps this goes on public records in assessor's office, or impacts sale of house? Per Slide 19: Even if a homeowner does not have an infiltration rate that is close to or exceeds the cost of infiltration, they should have a small fee to account for this, as they are contributing to the issue that all members of the town pay for. Perhaps this specific fee can go to the SEF to help fund these kind

Online	Shared	Sharing costs is a good idea. It's in the Town's interest to help get this solved. Reason I picked "fixed amount" is to give a break to people with short pipes on small lots. I figure people with large lots and long pipes are better able to afford the repairs.
Online	Shared	So many questions and comments; 1) will the town specifically identify lateral lines that needs repair? 2) will you specify the type of repairs needed or will it be a replacement? 3) We just got a notification the the street and sidewalk are about to be done next month, are you planing on destroying that work by scheduling pipes repairs after that? What kind of efficient scheduling is that? 4) The letter for the survey was pretty vague, i find it a bit annoying to be asked about cost share without even knowing what kind of money we are talking about or if my line even needs repairs. If the Town wants to get repairs done and paid for by property owner, i am asking that they identify specifically the lines needing repairs, the type of repairs and an approximate cost.
Online	Shared	some action must be taken to reduce the amounts imposed on residents for sewer bills
Online	Shared	Some home owners simply may not have the funds to excavate and replace sections of pipe that they didn't even know were damaged. For the city to demand it be fixed at the homeowners expense will get complicated if the city is imposing this on people of fixed or limited financial situation.
Online	Shared	Some homeowners are not going to be able to afford these repairs; in those cases the Enterprise Fund should pay 100%, for the good of the other rate payers.
Online	Shared	Thank you for offering the survey, it is great that Dedham is seeking this kind of public input.
Online	Shared	Thanks for asking, instead of just doing!
Online	Shared	The fund should be used to the maximum extent. If there is a way to apportion cost depending on the owner's ability to pay/size of property/value of property, it would be good for those who can afford it to pay more than those who have more hardship with paying.
Online	Shared	The fund that I as a homeowner pay into has been used to make repairs to public property already, so I should not be responsible for 100% of the cost of lines onto the property I have lived on for less than 3 years. Additionally, it is wildly unrealistic to expect that all Dedham homeowners have the funds to pay 5-10k, in a lump sum or otherwise. This has the potential to create a huge financial burden for many families and impact our ability to contribute to the Dedham community/economy.
Online	Shared	The town should also assist with any residence in the town that have septic or cesspools when the time comes to update their home systems to sewer if possible.
Online	Shared	The Town should help the homeowner is some way, whether its a no interest loan or the Town should pay for the work out of the sewer fees already collected There has been a tax on the sewers for decades and some of that money should be set aside for homeowner projects.
Online	Shared	The town should hire ONE contractor and negotiate a great rate. The town should pay for the repairs and impose a fee on each homeowner's property for reimbursement. The town should give the homeowner the option of spreading payments over a period of years. If the residents paid higher sewer fees because of the town's faulty pipes, then the town should pay in part to repair the resident's leaky pipes.
Online	Shared	The town should manage and verify completion of the repair. The town should bid the process for all repairs to be made for the up coming year. The town should select the best vendor and coordinate the process. This process should be whether the property owner pays 100%,, 50% or 0%.

Online	Shared	The Town should negotiate with the contractor/s, for discounted charge, since it is a substantial opportunity for secured income.
Online	Shared	The town would have to provide proof for each homeowner that their pipes have issues. Provide them with actual video proof of this. In addition tell the home owner (weeks in advance, not two days) when the town will be conducting the inspection of their pipes and ask them to be their during this time so they can see everything first hand (aka transparency from the town). Then provide the homeowner a report of the findings listing the issues, exactly where the leaks are located and an estimate as to how much this will cost them to replace. What is to say that a house with no leaks right now won't have them in 8 years. How often will these inspections take place? Will the same benefits that could happen now (low interest loans, 50% sharing in costs, or lump sum relief) will they apply then to those homes? What if a house doesn't have leaks and wants to update their system before anything happens. Will the town apply the low interest loan, cost sharing to them as well? What happens if a home owner pays someone (Roto Router \$200) to take a video of their pipes and they don't find any leaks but the towns claims they have leaks. Then what? This should also be in the notification to the people in town of what to do then.
Online	Shared	The work on my street finally moving to the street of the
Online	Shared	This could create a severe financial burden on seniors/retired people/people with fixed income.
Online	Shared	This is tough. It costs all of us when water seeps in, but what's the point of having private sewer connections if the Town is just going to pay for it? I ultimately settled on splitting the cost between the owner and the Town, but there should be limits. The split should only be for residential properties (commercial properties should pay 100%), but the Town should cap how much they will pay. The houses up in Precinct One that have mile long driveways should have to pay more. There's a big difference in what a guy in East Dedham or Riverdale can afford to pay and what someone on Westfield Street can pay.
Online	Shared	This is tricky! I think since everyone saves or suffers because of these I/I issues on private property, we would benefit from a public/private partnership. The cost is also quite high for some homeowners and would be most likely an unexpected and difficult expense. The town also should not lose control of this process by dictating to homeowners what they must do and then waiting for them to do it with the possibility of punishment if they don't. Is this what we want to take on as a town government? I would suggest coming up with some percentage to be covered by the town (enterprise fund?) that reflects the savings from reducing I/I. I see this being well below 50% of the costs Can any of the work be done by our wonderful DPW? Thanks for asking!
Online	Shared	This is very difficult for people on fixed incomes.

Online	Shared	this survey would be a lot more effective if you gave us an idea of approximately the average cost of repair? Are we talking 4 digits, \$10,000+ etc. Hard to give answers without knowing the costs.
Online	Shared	Town needs to negotiate contractor pricing - with requests for proposals for best solution least disruptive and volume discounts. Need to have competitive market rates - NOT like the attic insulation MASS saves program. If the town does not negotiate then it is best to allow the private owner to negotiate pricing.
Online	Shared	Town should be 100% responsible for any components of the lateral that falls underneath public domain land (e.g. roadways, abatements). Owner should be 100% responsible for any components of lateral within 10 feet of the connection to the main domicile. In unlikeley cases where the lateral lies underneath public domain land within 10 feet of the domicile, the town would be 100% responsible first for portions per first rule and homeowner thereafter for any remaining portion up to domicile by percentage of total cost. Any lateral more than 10 feet from home and under private property would be 50/50 responsibility of town and owner.
Online	Shared	Who has responsibility of repairing damaged pipes on private property now? How does the property owner know if they have damaged pipes underground? Property owners should be notified of damaged pipes so they can work with the town and company to fix them.
Online	Shared	Would like to be kept informed of the results of the survey, ans well as any changes to the way this issue is handled currently.
Online	Owner	Can the town save money on storm water by retaining storm water after storms and releasing it during dry weather at a lower cost? Handling storm water during the peak of a storm and after the storm is usually more costly. Could incentives be offered to private land owners to retain storm water from their property (parking lots, roofs etc) and releasing it during dry weather? Has Dedham looked at CMAC solutions for local detention centers / ponds for storm water? Could the town offer private land owners incentives to retain water in holding ponds/detention centers to treat storm water instead of having it pumped to MWRA? What is the town doing about private property owners who pump water out to the street? I regularly see homes have visible pipes/hoses they direct into the street. It's unfortunate these people have water problems, but there should be a cost associated with dumping water into street.
Online	Owner	Future housing inspections should have this testing done to ensure the buyer that the sewer is in compliance. This should be part of the Warrant to go before the Town Meeting. I'd like to thank the Engineering Department for working so diligently in tackling the infiltration problem.
Online	Owner	I don't believe I should haveto financially contribute to other property owners' deficient pipes on private property, and therefore most, if not all, costs should be contributed by the offending property owner. Thank you.
Online	Owner	I support this process
Online	Owner	I would assume that new homes and homes that have had sewer lines replaced (? Time frame) would be exempt.

Online	Owner	if the Enterprise fund is used to pay for part of the private repairs, it should be meanstested, capped, or both. We should not be using Water District resources to pay for repairs to privately owned pipes when the owners have the means and responsibility to do so. I do think that inspecting the privately owned infrastructure would be a valid use of common funds, since that is likely to be much more efficient than having each property owner conduct an inspection and have to certify that everything is in good repair. Moving forward, good condition on sewer pipes should be a requirement of sales, just like paying your bills and settling any liens is.
Online	Owner	Private property and the repair and maintenance thereof is inherently the sole responsibility of the private property owner. Each property is different pipes are different age, different materials, installed poorly or well, drain runs are different size and length, property owners control what flows through the pipes, what trees of what type are planted where that might affect drain pipes over time, etc. Should certain taxpayers be forced to subsidize the choices and behaviors of others? Discovery/diagnosis of I&I problems must be accurately and objectively executed and communicated to property owners. A reasonable period of time to cure should be provided, failing which financial penalties would accrue, penalties reasonably proportionate with the cost of I&I water processing and related administrative costs of billing and collecting and ultimately a Town water shut off right in order to induce resolution. A simple and efficient appeal process must be available for property owners to question, clarify or verify technical findings should there be reasonable reason to doubt the I&I failures asserted by the Town. The Town should not be in the lending business, a guaranteed losing proposition for the taxpayers. Lending is the domain of banks and other financial institutions. These are already set up to lend effectively and efficiently within an already existing regulatory framework. Responsible property owners, those who plan ahead financially and maintain their property, should not be compelled to subsidize or lend to those who do not. Though they may unhappily look at their neighbor's deteriorated conditions above ground, e.g. rotten siding, crumbling chimneys, taxpayers are not (nor should they be) responsible to help pay to correct these things. Because a drain pipe happens to be underground or connected to a municipal sewer system does not make it any less the homeowner's responsibility or somehow how create an obligation on the part of their neighbors

Online	Owner	Thanks for initiating a solution to this wasteful situation. It would be helpful to show the return on investment for capital spent both by the town for its repairs and for private residents/businesses for their repairs. In the end everyone is responsible for the sewer costs they incur, but low cost loans should be used to help people who are not prepared to face this expense. I would guess that the money saved on solving this issue will provide a better return on investment than the Towns financial investments which would justify from a financial perspective at least being much more aggressive about solving this issue than might otherwise be considered.
Online	Owner	The Town should look at the DWWD rules and regulations regarding the home owners responsibility to fix service connections entering there home.
Online	Owner	We recently had to replace the entire sewer pipe on our property. The Town of Dedham refused all financial assistance since the pipe was on private property and we had to pay the entire bill. Should The Town of Dedham take a different position going forward and offer homeowners financial assistance to repair / replace sewer pipes on private property we would expect the town to reimburse us proportionally for the work we recently completed.
Online	Owner	What bothers me is the sewer project has been going on for years and we are told the amount of leakage is in the millions of gallons seeping into the system. I would hope some progress has been made that would have reduced the amount of non-sewer water going into the system.
Online	Owner	Why would it be any different than if your sewer line breaks on your property or if a tree root grows into the line? The property owner owns the line to the public way and is responsible for all repairs. However, rather than using a stick and penalizing home owners for not complying, it is in everyone's best interest to give homeowners INCENTIVES to fix these leaks. In my opinion, a low or no cost loan from the sewer fund is absolutely an appropriate use of these funds and I would contend that the loan should be amortized over a longer period than 2 years - maybe even 10 years (or until the home is sold), at which time it must be paid in full. The average homeowner is generally ill equipped nor do they have the information, knowledge or expertise to be able to thoroughly vet a site contractor. Anything the town/DPW can do to pre-qualify contractors would go a long way to assuring homeowners that the contractor they hire is legitimate and responsible.
Online	Owner	You should develop a fair market approach to correct the problem. Each homeowner should be responsible and pay for having their sewer inspected for infiltration and corrected if the pipe has infiltration. The correction method is at the discretion of the homeowner. If the town wants to dictate the corrective method, then the town should pay for the work. Once a home is certified as leak free, the infiltration surcharge should be remove from the homeowner's sewer bill and only those with non-certified infiltrating sewers should be responsible to pay the surcharges. So if 30 % of the buildings in Dedham currently have have no infiltration, one can deduce that the remaining 70% of the buildings are 100% responsible for the cost to treat the infiltration and only their bills would include a surcharge. As building owners determine that it is more cost effective to fix the problem, they will actually fix the problem or sell the property. Here low interest loans would work. The town should require any one that sells a property, have the sewer line inspected for infiltration and corrected as a condition of sale. This would be similar to the septic system laws
Online	Sewer Fund	A lot of residents are on a fixed income, and others live pay check to pay check. Where do you think they will get the money from? Dedham residents pay a lot in real estate taxes too. Dedham is not going to be a desirable area to move to anymore with the residents expecting to pay for everything. Now I know why everyone seems to be selling their homes in my area.

Online	Sewer Fund	As a home owner in Dedham who purchased a home built in the 1960's I have no control over what type of pipe was installed or how it was maintained until the purchase of my home. Requiring homeowners to carry 100% of the cost of this program could put a large burden on my families finances as it would be a very unexpected expense, not something we planned for when buying our older home.
Online	Sewer Fund	As the Town has seen fit to direct some of the money paid on our sewer bill to a separate fund, then the whole expense should be paid from that fund.
Online	Sewer Fund	Assessing private citizens costs for repairs to town sewer lines is a unfair financial hardship. They are unlike a septic tank which a private owner has the ability to maintain to ensure optimal performance.

It's as if rules will only be imposed if the property owner is paying some or all of the cost, but if the cost is entirely the fund's responsibility then the parties can do as they like (e.g., take more than a year to complete necessary repairs), unless there are rules written somewhere else pertaining to this situation.

What shape are they in? I strongly feel this is the town's responsibility.
Online	Sewer Fund	I have been paying into the sewer enterprise fund, i expect to be protected by my contributions into it. As a longtime resident, i speak for any private residence, not a commercial or industrial customer.
Online	Sewer Fund	I have lived in the northeast, south and midwest, in multiple communities. Never have I been responsible, as an individual homeowner, for sewer replacement, maintenance and upkeep. This is what I'm paying for with sewer fees and ,more generally, property taxes.

Online	Sewer Fund	I have no idea how much something like this would cost to fix, but I do know that many households are on a budget. If fixing these issues would be a financial burden to homeowners, I think that there should be help, like mass save. For example, low interest loans, a reasonable amount of time to payoff the cost, a reasonable amount of time to get the repairs done. If you came to me in December and said it needs to get done in 6 months, it's unfair - time of year, might cost extra because of frozen ground, weather could be a factor, etc. I like the idea of it being split with the town.

Online	Sewer Fund	I strongly suggest that the town pay a majority of the repair costs because infiltration is probably something that many home owners are unaware of and because these costs could range from 5-20 thousand dollars which most families do not have on hand for surprise repairs.
Online	Sewer Fund	I suggest, assuming the owner pays any portion of the repair, that the Town offer a NO Interest loan. This would be a loan similar to the Mass Save no interest loans. It's not fair, or ethical, to charge the owner interest on monies they already paid into the fund for repair purposes on their monthly bill. Essentially, you are taking their money (additional fee for repair fund) and then lending it back to them, with interest. Also, why doesn't the town get a low interest loan and pay for the repairs? So, it would just be bad luck if, for instance, I had an issue and my next door neighbor didn't. Therefore, I don't think individual homeowners should have to pay for repair of their line. I wouldn't be opposed, however, to all homeowners paying a very small amount into the fund to repair lines in the town, sort of like a small insurance premium. Also, on a related note, why not have more education and outreach about how people can reduce their water usage (for example, as a workshop at the library, etc.).
Online	Sewer Fund	It seems to me based on the estimates provided that the repairs will pay for themselves in 5-6 years even taking estimates of repair costs to be on the high side of what is quoted. So if nothing else, a fair portion should be offset for the owners of pipes on private land. Again, a definition of what makes pipes public or private would be helpful, though it should not matter. This is surely a more complicated issue than I have a grasp on; had I been able to attend the meeting then I'd hopefully understand more and understand why there is such a discrepancy in costs when all water uses are affected by infiltration. The time limit for each property should begin with the failing diagnosis and allow extensions for circumstances which are out of the owner's control, like contractor availability. (It is easy to be cynical about contractors after the experience with the new town hall.) 6. Failure of a property owner to upgrade should result in a property lien which would force the work to be done before a property transfer. Any other type of financial penalty will be difficult to enforce. 7. How is the method of remediation determined? The average cost estimates in your PowerPoint presentation would be more helpful if they were included with this survey. Property owners will face big additional expenses if landscaping, walks, and fences will be removed for access to their sewer lines. 8. The Dedham sewer infiltration problem includes many of the difficult issues facing our country like water quality, public spending, deteriorating infrastructure, and community cooperation. As you have noted this is a community problem that needs a community solution.

The Town has about 8,000 customers, so that is roughly \$28 per customer for the year. The Town inspected approximately 20% of the entire Town's Public system in 2018. If we extrapolate the data for the remaining 80% of the Town, there is a potential that there are approximately 300 private sewer services contributing approximately 700,000 GPD of infiltration into the Town's sewer system costing customers about \$1,134,000 in FY2018 or about \$142 per customer for the year." I sure would rather pay \$28 or \$142 per year indefinitely than \$5,000 to \$20,000 over two years. Is a private infiltration policy mandated by the Commonwealth or is just something the Town wants? If it's the latter, I can't imagine why you would contemplate imposing this enormous cost on residents. This needs to be 100% paid for for by a town enterprise fund. It's expensive enough to live here! Will failure to make improvements inhibit the sale of a home? For example, will a home owner need to show a certificate of completion in order to sell? How are other towns handling this? I haven't heard any friends in other towns paying thousands for these repairs. We have many severely blighted properties in town that are abandoned. The owners of these blighted properties have rebuffed the repeated pleas of neighbors to sell or fix their property.
