On November 30, 2020, Dedham's Town Meeting Representatives voted and approved plans to begin construction on the Combined Public Safety Building.

This project is expected to be completed in the summer of 2023.

Mucciaccio Pool Building-Window Replacement Project


Work has begun on the installation of the new windows at the Mucciaccio Pool Building.

I. New support steel has been welded to the existing steel beams at the top (Photo I {2020-II-I0})


2. Panel installation begun on South elevation of building (Photo 2 {2020-11-20})


3. First 4 panels completed on South side thru 11/24/2020 (Photo 3 {2020-11-24})






Demolition of Old Town Hall

A Virtual Design Public Hearing will be published on the MassDOT website below to present the design for the proposed Bussey Street Pedestrian Improvements from the Boston City Line to the East Dedham Fire Station, near Chauncy Street, in Dedham, MA. The project includes the superstructure replacement for the bridge crossing Mother Brook.

WHEN: Wednesday, December 9, 2020

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Bussey Street Improvement project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The purpose of this project is to improve pedestrian and bicycle accommodations and safety along Bussey Street from the Boston City Line to approximately 150 feet south of Chauncy Street. Proposed improvements include pavement milling and overlay, sidewalk reconstruction that are ADA compliant, a flashing beacon, and new signs and pavement markings. The project includes the superstructure replacement of the bridge crossing Mother Brook. Bicycle accommodations by means of shared lane markings in the travel lane are provided along the corridor north of Colburn Street, and a usable shoulder is provided on each side south of Colburn Street in accordance with applicable design guides.

A secure right-of-way is necessary for this project. Acquisitions in fee and temporary easements may be required. The Town of Dedham is responsible for acquiring all needed rights in private or public lands. MassDOT policy concerning land acquisitions will be presented in the hearing.

Written statements and other exhibits regarding the proposed undertaking are to be submitted to Patricia A. Leavenworth, P.E., Chief Engineer, MassDOT, 10 Park Plaza, Boston, MA 02116, Attention: Project Management, Highway Design, Project File No. 607899. Mailed statements and exhibits intended for inclusion in the public hearing transcript must be postmarked no later than ten (10) business days after the hearing is posted to the MassDOT website listed below. Project inquiries may be emailed to dot.feedback.highway@state.ma.us.

This hearing is accessible to people with disabilities. Planning Board Update

The Planning Board on November 12, 2020 approved the proposed construction of a new corporate headquarters for Norfolk & Dedham Group at 222 Ames Street by the Norfolk & Dedham Group. The proposed project would demolish Norfolk & Dedham's existing 41,070 sq. ft. office building and construct a 53,000 sq. ft. new office building with 179 off-street parking spaces. "As a business that has been located in Dedham since 1825, we are happy to have Norfolk & Dedham continue to call Dedham home for the next 100 years", said Planning Board Chairman John Bethoney. The project is expected to begin construction in Spring 2021.
