### Town of Dedham Awarded Grant from MassDOT for Outdoor Dining Platforms

The Town of Dedham has been awarded a \$40,000 grant from the Massachusetts Department of Transportation (MassDOT) as part of the Shared Winter Streets and Spaces Program to reinstall ADA-compliant outdoor seating in Dedham Square.

The Town of Dedham is one of 21 municipalities to receive grant funding through this program and the total investment by the MassDOT to support these 21 projects is over \$3.2 million. Following the success of temporary outdoor seating areas in the Dedham Square during the summer of 2020, the Town of Dedham will use this grant funding to reinstall custom ADA-compliant seating platforms in the same locations in Dedham Square. The platforms are designed to extend the sidewalk, creating a level, accessible surface for outdoor dining.

Using the same footprint and on-street parking spaces as in 2020, these platforms will provide safe and adequate space to ensure social distancing measures can be maintained at local restaurants. The platforms are designed to be temporary in nature to enable the Town to adjust the application as needed in response to the Covid -19 pandemic and public health requirements. While providing these additional seating options for local restaurants, these platforms encourage safe mobility across all modes of transportation in the area and promote outdoor recreation and local commerce.

The MassDOT Shared Winter Streets and Spaces Program was created in June 2020 in response to the Covid-19 pandemic and the impact it has had on daily life. With respect to mobility and transportation, the need to ensure adequate, safe space for social distancing has become paramount and of primary focus by the MassDOT. This grant program encourages municipalities across the Commonwealth to identify ways in which they quickly can creatively meet the needs of residents and provide for safer outdoor recreation and community engagement. To date, the MassDOT has allocated \$10 million to this program.



#### **Dedham Public Safety Building Project**

Excavation has continued through the winter. The Project is now ready to start foundation work. A groundbreaking ceremony will be held on Friday, March 5, 2021.

- 4. Excavation nearing completion, ready to start foundation work (3/2/2021)










A Request for Qualifications (RFQ) was issued for Design Services to begin the reconstruction process of the Endicott Estate Barn.

- The RFQ was Issued on 2/3/21 and resulted in twenty-nine firms showing interest and requesting a copy of RFQ.
- An informational/briefing session was held on 2/9/21 over a Zoom remote session in which there were sixteen attendees from various firms.
- ♦ Proposals were due on 2/25/21 which has resulted in four finalists.
- Proposals are being reviewed by the selection committee which anticipates to start interviewing firms on or about 3/24/21.

#### No Heat in Rear Wing of Greenlodge Elementary School

On Monday morning February 8, 2021 we lost heat to the rear wing of the Greenlodge Elementary School due to corroded underground heat supply pipes. Due to the lack of heat, it was necessary to close the rear wing and relocate classes or move to remote learning. The Facilities staff and consultants rallied to identify solutions to bring temporary heat to the six classrooms and Library to prevent freeze-ups of the uninvent heaters and plumbing in these spaces, all while overnight temperatures were in the teens. We removed a window to feed flexible ductwork from a rented Frost Fighter Heater into the building and fans were placed in the hallway to direct heated air throughout the rear wing. A 1000 lb. propane tank was installed inside the dumpster fence enclosure to fuel the portable heater. We appreciate the Building Department inspectors and Fire Department staff approving the plan for the temporary heater installation as well as the permanent boilers installation with very short notice. #### No Heat in Rear Wing of Greenlodge Elementary School (cont.)

After obtaining a DCAMM waiver on Wednesday February 17th for the emergency procurement, PJ Kennedy was contracted to install two new high efficiency Lochinvar 400,000 btu boilers in a supply room that also houses the network server equipment. Our asbestos contractor needed to remove the asbestos flooring prior to any work being done as well. The existing heat supply lines were cut and capped and the new boilers, pumps and expansion tank were all installed in four days during the latter part of the February vacation week, which was a Herculean task to say the least!





We successfully started up the new boilers on Sunday February 21<sup>st</sup> and all went well with inspections, so students and staff were able to return to in-person learning on Monday February 22<sup>nd</sup>. Since these photos were taken the pipes have been insulated, a fire separation wall is being constructed, and Siemens sensors were installed to monitor the boilers remotely. In the Spring, we will install a new gas line to feed the boilers and we can remove the temporary propane tank from the dumpster enclosure.

Job well done! A huge thank you to all involved in this successful emergency project.

Free Third Thursday Webinar St. Mary's Church: Building a Community Thursday, March 18, 2021, 7:00 p.m.

On May 15, 1843, eight people attended the first Catholic Mass in Dedham. It was held at the Slattery House and celebrated by Father James Strain of Waltham. As the town's Catholic population grew, largely from an influx of Irish mill workers emigrating due to the Potato Famine, the community needed a place of worship. This webinar, presented by Jack Hoell, will discuss the construction of what is now St. Mary's Church, the struggles of the parishioners to earn acceptance, and how other residents of Dedham bonded together to help build a monument to the beliefs of the Catholic community in town.

## Commendation for Excellence in CIT Officer Jason Sullivan



Officer Jason Sullivan has been a police officer in Dedham for 8+ years. Officer Sullivan has gotten involved in several efforts to support members of the community as a Police Officer for the Town of Dedham. When District Attorney Morrissey solicited officers to be trained as Naloxone trainers for their Departments and communities during 2014 to help address the opiate epidemic, Officer Sullivan attended the training and subsequently trained all Department members in recognizing overdoses and the administration of nasal Naloxone. The training provided by Officer Sullivan allowed for the Department to deploy nasal Naloxone resulting in officers successfully administering this life saving drug and reversing overdoses many times. Officer Sullivan continues to be available for training and he tracks nasal Naloxone administrations as well as the Department supply of this drug. During the fall of 2016, he attended the 40 hour Crisis Intervention Training hosted by the Brookline Police Department.

He has attended monthly mental health stakeholder meetings. These meetings discuss situations in the community with individuals experiencing either mental health or substance problems. Officer Sullivan has conducted follow up visits with community members as a result of these meetings. Officer Sullivan has been one of the Department's School Resource Officers since May of 2018. In this role, Officer Sullivan constantly works with and builds relationships with youth in the community and Dedham Public School staff. He is a resource, mentor and pillar of support for youth and their families on a daily basis. He took on the role of Community Resource Dog Handler during January of 2020 and hosts the Department's dog at his home. This involves training and care for the dog. Officer Sullivan and our Community Resource Dog provide a calming presence for community members in crisis as well as an outreach tool to engage members of the community. The Town of Dedham was awarded a Drug Free Community grant which led to a restructuring of the Town's Coalition on Substance Abuse. Officer Sullivan has since represented the Department as a Youth Action Team Leader as part of Dedham's Organization for Substance Awareness. To educate liquor license holders, Officer Sullivan became a T.I.P.S certified instructor and has conducted training for local liquor license holders. He represents the Department as a point of contact maintaining data and conducting overdose follow up visits as part of Norfolk County's Outreach program. In this role, he along with either a recovery coach or the Town's Public Health Nurse provide resources and encouragement for those in the community who are struggling with substance mis-use.

## **Dedham Police Department**Hybrid Cruiser Joins Fleet of Police Vehicles



On February 24, 2021 the Police Department deployed its first hybrid police vehicle. This is a police package vehicle designed to meet the needs of an emergency response vehicle. We estimate that these vehicles could realize a savings of up to 1,500 gallons of fuel annually when used in a 24 hour per day capacity.

### Protect Your Vehicle Against Catalytic Converter Theft

Several reports of catalytic converters being stolen from vehicles have been received recently. These thefts have generally been from vehicles parked in commercial parking lots, but any gas powered vehicle could be victimized. It is expensive to repair a vehicle after having a catalytic converter cut away and stolen. These items are targeted for the metals they contain which can be sold as scrap metal. Some guidance to protect your vehicle provided from insurance industry sources include: park in well lit-areas, park inside your garage if you have one, park in a way which makes it more difficult for a person to get under your vehicle (e.g., close to curbing), etch your vehicles VIN number on the catalytic converter, if you have a car alarm which can detect vibrations-configure this feature, install motion lights and park within range of such lights, install a security camera to cover the area where you park. You could also ask your mechanic about ways to weld or attach equipment to make it harder to remove a catalytic converter.



#### 2021 Sewer On-Call Services Contract



A bid opening for the Town's 2021 Sewer On-Call Services Contract was conducted on 2/4/21. The apparent low bidder was National Water Main Cleaning Company from Canton, MA with a bid price of \$899,123.70. The work under this contract includes emergency cleaning services, cleaning & inspection services, wet weather cleaning and inspection services, trenchless repair (lining) services of sewer mains with observed infiltration and rehabilitation of sewer manholes with observed infiltration. We are finalizing the contracts and anticipate sending out a Notice To Proceed by the first week of March. The work under this contract will start in March and is to be completed by December 31, 2021.

## 2021 Private Infiltration Removal and Investigation Contract

An Invitation For Bids was sent out in February for this contract. The bid opening is set for Thursday, March 4 at 10:00 AM. The bid will be awarded to the lowest responsible and eligible bidder. The work under this contract includes the lining and repair of private sewer laterals that have been previously observed as having infiltration. Additional investigations for private sewer laterals where equipment could not access will also be conducted under this contract. The work under this contract is anticipated to start in April and is to be completed by December 31, 2021.

This contract is a collaboration between DPW and Engineering.

#### **CY2021 Asphalt Paving and Resurfacing Contract**



A bid opening for the Town's CY2021 Asphalt Paving & Resurfacing Contract was conducted on 1/5/21. The apparent low bidder was Rochester Bituminous from West Wareham, MA with a bid price of \$792,087.50. The work under this contract includes various forms of asphalt paving and resurfacing including but not limited to full depth reclamation, grading and compaction, cold planning, paving, installation of bituminous and granite curbing, installation and repair of bituminous and concrete sidewalks and other miscellaneous work. The contractor will be repairing the roadways listed in the approved CY2021-CY2022 Road Program under CY2021. The Notice To Proceed was executed on 2/3/21 with a contract start date of 3/1/21. The work is to be completed by December 31, 2021.

## Department of Public Works Snow and Ice

We are recovering from an 86-hour storm event that dumped 7" of snow over that time period but was a major salt user for the safety of our roads and parking lots. The DPW uses a liquid organic brine that we mix with our salt, but it can also be applied directly to the roads and it is non-corrosive. This product is a beet juice derivative, but I wouldn't drink it! We moved to this product last year because our equipment was being eaten by chemicals and the life expectancy is dropping by 8 years on some vehicles. At the end of every season there is always street signs, directional signage and other signs that have been hit and knocked down and in need of replacement. If you see a sign that is knocked over and needs to be repaired, please email or submit a service request form on the Town Website. The DPW appreciates all your help and efforts to keep our roads and sidewalks clear during and after snow events. If you have a sidewalk in front of your home please remove the snow from it to provide pedestrians a safe route to walk on.

#### Roads and Sidewalks

Our road contractor, Rochester Bituminous, has been awarded the job and we are in the process of scheduling the road work now. We will give written notice thru door flyers on the status of your road or you can email Joe

#### **Shared Street Cedar Street Project**

We were awarded \$286,000 last fall for the Cedar Street Sidewalk project and we will be working on this project beginning in April. The project was delayed last fall due to Covid-19 issues. This grant is for granite curbing and a concrete sidewalk on one side of Cedar Street from Madison Street to Circuit Road. There currently is no sidewalk in this location. No private land takings were required to make this sidewalk happen. We want to thank all the homeowners for their extended cooperation on this project.

#### **Eastern Ave Complete Streets**

We will be bidding this job in March and construction should hopefully begin in late April. We were awarded \$400,000 dollars for new granite curbing and sidewalks along Eastern Ave from East Street to Rte. I. We will also be installing two rain gardens and upgrading the stormwater system in Eastern Ave. This project also had three RRFB crosswalk upgrades. One was at Eastern Ave by the American Legion Parking Lot, the other at Barrows and East Street and the other at Clark at East Street.

#### **Old Village Cemetery**

We will be bidding the Howe Family Lot ornamental fencing restoration and this project should begin in early May with a completion date sometime in late Fall 2021. Our grounds work on this Historic site will continue in April.

#### **Stormwater**

We clean catch basins every day above 40 degrees. Please refrain from dropping dog waste into catch basins. They are not sewers and not made for trash. These basins flow to our wetlands and this is a resource we need to protect. Dog waste in plastic bags collects in the basin and in pipes that causes blockages in our system.





#### Please properly dispose of your pet waste.

We will begin our street sweeping program in the next couple of weeks and please keep your catch basin free of debris!
