Chairwoman Moran thanked Dedham Cable for recording the meetings

Commissioner Dello Iacono asked for a moment of silence in remembrance of the 20th anniversary of the tragedies of September 11, 2001.

Chairwoman Moran stated that the Charter Commission has recommended that the Director report to the Town Manager.

A. O'Connell stated that she agrees with the Charter Commission, and all would be better served if the Director reported to the Town Manager.

Commissioner Dello Iacono stated he does not agree, the hiring of the Director would then fall under the Board of Selectman. The Commission has not been represented fairly by Council, he would suggest a substitute motion and request their own Town Counsel.

L. Farnham asked what the Director thought of the change.

Director Stanley stated that he has gone back and forth over the years, he thinks it may serve the town well to report to the Town Manager. He is leaning toward the Charter Commission change.

Chairwoman Moran stated that she spoke to the Town Manager, and he stated that the Commissioners would not be left out of the hiring process in the future.

- A. O'Connell stated that it would be an Advisory position of the Director.
- C. Dello Iacono stated that the current Town Manager may not be in that position when it comes to the hiring in the future.
- J. Briggs stated that there are pros and cons, and he doesn't see the negative in the Charter change, and he is in support of the change. If there were to be a substitute motion what would the timeline be?

It was answered that a placeholder could be put in the warrant and then be able to put in the proper wording.

C. Dello Iacono stated that a substitute motion could be made up until Town Meeting

Chair Moran stated that she was against the change, however she is now in favor of the Charter Commission recommendation. The Selectman have asked for the Commissioners to take a vote

- J. Briggs stated he doesn't understand the need for this Board to take a vote on this.
- L. Farnham asked to see the final language of the article

It was answered that the final language would be in the motion.

J. Briggs made a motion to take a vote in principle to support the change with a second by A. O'Connell Roll call vote

- C. Dello Iacono stated that he appreciates all that the Director does and a proud moment was when the Director was able to help the Police Dept. by turning all the lights on at the various fields.
- J. Briggs stated that outside of the day-to-day operations the department does so much for the community. He has received many compliments this year about the fields.
- L. Farnham has asked many questions of the Director and appreciated the patience and assistance.
- A. O'Connell stated that the Director does a great job, and that working together with the entire Department. So happy to see how things worked out with the retaining of the Pool Director.

C. Dello Iacono stated he had asked Kristen Spencer, who runs the Pathfinder programs, to join us tonight.

Shari Laurent is inquiring if a playground could have some time for children with special needs set aside, for them to utilize the playground for safe places to play freely.

- J. Briggs asked if it was the structures at the playgrounds or times that she is looking for.
- A. O'Connell asked if there were play areas that she likes best.
- S. Laurent stated that she does go to Memorial or sometimes Paul Park. Lately they have been going to the ECEC.
- C. Dello thanked Shari for coming in and sharing her story, he stated the Condon has the Pour and Play surface. He stated that he had spoken Kristen Spencer who would be happy to work with her on this initiative.

Chairwoman stated that she appreciates S. Laurent for advocating for her son and all children with disabilities.

Director Stanley stated that in the future when new playgrounds are built these needs will be considered. It would be easy to have a few hours to etch out for this suggestion. He stated he could work with Shari to come up with a plan, and post signage with some notice. Possibly at those times have a staff member at the park.

A. O'Connell stated that she is hesitant to close a park and possibly there are families in the community that would be understanding and participate at the playgrounds at those times

Chairwoman Moran stated that she feels the community would be happy to be accommodating.

D. Anderson stated that there is a Pathfinders Swim time at the Pool and we don't close the pool to other families.

Kristen Spencer is happy to start back up with Pathfinder Programs, Sepac is a great resource. We have great success with our participants. We have all inclusive programs such as Mini Chefs, movie nights, swim, a winter track program at Ursuline Academy and bowling nights. She offered to work with and assist in any way she can.

Permit Policy Discussion & Vote

Chairwoman Moran stated that there would not be a vote this evening.

Signs Policy Discussion & Vote

Chairwoman Moran stated that we would not be taking signs down

- L. Farnham had questions regarding who would be putting up and removal of the signs?
- C. Dello Iacono stated that surrounding towns have timeline lines on when signs can be put up and taken down.
- J. Briggs stated that we need language that specifies what types of signs would be allowed.
- A. O'Connell asked about Youth Group signs that are permanent, such as at Memorial backstop, and concession stand at Rustcraft.

Director stated that those signs were approved years ago

J. Briggs stated that the Commission has the right to deny any signs at any time.
