## Meeting Minutes of September 09, 2021

The Board of Health meeting was called to order at 5:36 PM on Thursday, September 09, 2021.

# 66 Norwell Road

Assistant Health Director Leontia Flanagan explained that she was dispatched to 66 Norwell Road on August 24, 2021, to inspect the premises based on concerns from emergency medical servies. John Bithoney, property owner, was identified and provided permission to inspect home and property. Assistant Health Director Flanagan and Building Commissioner Ken Cimeno inspected the property. Unsafe and cluttered conditions were observed, including but not limited to non-working/non-present fire and carbon monoxide detectors, blocked egress points, an inoperable sink, non-working stove, and a mouse infestation. Health Director Sullivan referenced memo that was sent to Board Members outlining five items that would deem this dwelling condemnable according to 105 CMR 210.000: Minimum Standards of Fitness for Human Habitation.

The Board discussed improvements that have been made to the property since August 24, 2021. The Board expressed concerns about the health, safety, and well-being of occupants. No representative for 66 Norwell Road was present at the meeting to provide clarification of status, or the projected plans to improve the conditions of the property.

The Board arrived at a consensus that the dwelling's current state is not suitable for human habitation. Vice Chair Mary Ellard made a motion to condemn 66 Norwell Road. The motion was seconded by Member Noreen Guilfoyle. The Board unanimously voted to approve the motion and condemn the dwelling located at 66 Norwell Road based on the current conditions observed, which are unfit for human habitation and safety. The Health Department will post the condemnation notice and order to vacate to alert the occupants based on the Board's decision.
