Steve Bilafer indicated a family connection to the umbrella corporation of CBRE. The family member does not work for a division or in a capacity relating to project management and committee agreed that there was no conflict. Nonetheless, Steve felt that he should recuse himself from the process in an abundance of caution to avoid possible question arising regarding conflicting interests.

Each remaining SBRC member, and Denise, reviewed each proposal. During the course of the reviews there was limited discussion. It was noted, however, that two of the candidates proposed a joint venture with the project manager for Dedham Town Hall. Given the substantial difficulties with the Town Hall project, including cost overruns, delays and litigation, all agreed that this association was a negative for these candidates and that the candidates would not be considered.

After reviewing all candidate packets, members discussed pros and cons of each candidate in accordance with the MSBA suggested matrix to be used for grading the candidates. After several hours of discussion and review, each member and Denise ascribed a score to each candidate. The following table lists the scores given to each candidate:
