Dira Johanif: Urban resiliency advocate CRWA Robert Kearns: Climate resilience specialist CRWA

Goal: discuss idea and recommendations re Dedham building its resiliency Can CRWA partner and build resilience?

Overview of CRWA mission/history

Climate change impacts and importance in watershed, flooding likelihood and impacts—good opportunity to do some planning

Stormwater runoff overview and phosphorus pollution

How much impervious cover—we are about in the middle, and are fairly high in vulnerability index

Municipal Vulnerability Preparedness: More intense storms, heat, droughts, This is on town www site

Climate Compact-Dedham is part of it—climate compact and flood model-Jeremy Rosenberger attendsdiscusses ways to adapt to climate change CRWA Showed map of flood areas in Dedham Culverts and streams are being analyzed

Including: middle school area, which is also a shelter

NEPRA is working on one for Neponset watershed-some of Dedham is in Nepoonset watershed

Recommendations to build resilience:

- Adopt stormwater utility
- Strengthen tree protection
- Strengthen wetlands bylaw

CRWA has looked at Dedham's Climate action and resiliency plan

Actions for Dedham:

- Prepare all residents and businesses
- Green infrastructure
- Make sure utilities are prepared
- Increase tree canopy to 65%

stormwater utility—dedicated revenue source for staff, education, and green stormwater Funds fixing drainage and complying with MS4

Stormwater utility: related to pavement owned-a fee charged based on pavement (public, private) Cost? "Not a lot"

If implemented, are there are mitigation steps?

Lots of education done in the 24 communities that have a stormwater utility?

Tree cover canopy Create town wide tree protection policy (in our CAP) Protect private trees/trees on private property Climate resilience objectives and language through a tree bylaw

#3

Wetlands

There are more than 1,200 acres of wetlands in Dedham Dedham unique has a large amount of the natural valley storage area (Cutler Park) for water storage *include climate change to protect wetlands—isolated wetlands as well as intermittent streams Use up to date climate change data and maps

Environmental justice:

Re how to mitigate and how to plan: we have 7 EJ block groups, communities most vulnerable (state has map)

EJ and equity goals: increase access to water

CPA: community preservation act is a climate resilience toolkit (funding thru property tax)-open space, improving recreation, affordable housing, historic preservation

Dams:

Slows water, lowers DO above dams, water temp increases above dam Discussion of fish and dams-if dams removed below Dedham, would more fish species be here? Answer: yes, historical records of shad and alewife farther up river, even salmon
