Member updates

Chair:

Riverdale "Walk and Talk" of June 23rd follow up

30 residents over the span of an hour about their observations, experiences and concerns about this intersection (and others). Everybody expressed issues with this intersection in some shape or form.

Summary of Group observations:

- *the Stop signs and markings*: They aren't where cars natural want to, or should be stopping. Most cars we observed in this time span did a rolling stop beyond the Stop sign area, where they can get better visibility throughout the intersection. Some attendees shared stories of getting citations from the police (generally speaking) for not stopping at Stop signs. They said its often because the **Stop signs are poorly located**
- *Pedestrian markings and routes*: When asked 'where should pedestrians cross in this intersection", there was a variety of answers and routes. This is because there are **no obvious crossing points** due to lack of curb cuts, position of the Stop signs and lack of sidewalks throughout the intersection. This is concerning because traffic flow (pedestrian or vehicular) should be predictable, to keep everyone feeling safe and physically safe too.
- *Car speeds*: Cars can flow and turn quickly through the intersection along Vine Rock. Some residents stated how there had been calls in the last 2 weeks to the Dedham PD to share and report specific concerns.
- *Lighting at nightime*: Only one light was observed on the NE corner, which is the only corner that has zero sidewalks. The above concerns are exacerbated due to poor pedestrian visibility as well.
